



Gábor Tóth – Representative of finance MAM Kft., Chairman Gábor Nagy – CEO finance of Kopaszi Gát Zrt.



- Coupon: 5,75%




From the whole amount of proceeds, HUF 16 753 392 825 (48.6% of the total amount) was spent until 30/06/2023. In the first half of 2023 HUF 2 390 119 966 was allocated. All actual allocations meet the eligibility criteria of the Kopaszi Gát Zrt's Green Finance Framework. The unspent proceeds of the issuance are deposited in commercial banks.
